A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA ADOPTING THE CITY OF PACIFICA 2020-2025 CAPITAL IMPROVEMENT PROGRAM

WHEREAS, pursuant to Government Code Sections 66002(b) and 65090, City Council held a noticed public hearing regarding the City of Pacifica 2020-2025 Capital Improvement Program at its regular meeting of June 8, 2020; and

WHEREAS, the City of Pacifica 2020-2025 Capital Improvement Program indicates the approximate location, size, time of availability and cost estimates for all facilities and improvements that will be financed with those fees that are levied by the City on new development in order to fund public capital improvements necessitated by such development; and

WHEREAS, pursuant to Government Code Section 65103(c), the Planning Commission of the City of Pacifica reviewed the City of Pacifica 2020-2025 Capital Improvement Program for consistency with the City's adopted General Plan.

NOW, THEREFORE, the City Council of the City of Pacifica does hereby adopt the City of Pacifica 2020-2025 Capital Improvement Program.


