# Minutes of February 8, 2011 Approved 3/8/11

#### 1. Call to Order

Chair Murphy called the meeting to order at 6:12 pm.

# 2. Approval of January 11, 2011 Minutes

# 3. Branding Discussion

Sam Casillas told about meeting with interested people on branding. They were eager to be involved in the process. Courtney Conlon told about the Chamber's involvement in the branding process and its desire to help move the process along quicker. Discussion followed on how to do this and it was agreed that the EDC would work with the Chamber to develop the branding program for the City as fulfillment of one of the committee work tasks.

She asked if this was a task that the subcommittee could tackle. Courtney Conlon will find out more information regarding the sign issue in Rockaway Beach.

A member of the audience, Vasu Naranayan from Oceana Market, told about the effort to coordinate signs in Eureka Square and also talked about promotional programs that he has seen in other areas.

**SC #3** – There was no report from the subcommittee beyond the branding discussion earlier in the agenda.

### 5. <u>Update on General Plan Meeting</u>

The City Manager gave an overview of the General Plan Update meeting that was held on January 29, 2011. The meeting was well attended and there was good discussion among the participants. While some attendees were concerned about the content of the material that was presented there was still plenty of discussion and written feedback was provided to the consultants.

The committee discussed the meeting and the next steps for the General Plan update process. Staff explained that further progress will depend on the availability of funds in the Budget in the next fiscal year which begins July 1.
