Commissioner Blackburn spoke to the commission about upcoming dates for the Vegetation Management Chipping Program that is a part of the grant project managed by the North County Fire Authority (NCFA). The program promotes protecting structures

**UNFINISHED BUSINESS:**

Commissioners inquired about an update on traffic and parking concerns near the Mori Point trail head. The Open Space and Parkland Advisory Committee is working on this matter, and Captain Clements will contact the staff liaison for further information.

**NEW BUSINESS:**

Commissioner Crawford shared some traffic safety concerns on Skyline Boulevard at the Hickey Boulevard intersection, and southbound Highway 1 at the Manor Off-Ramp. Commissioner Crawford proposed measures could be researched to improve visibility at the Highway 1 off ramp. Captain Clements pointed out the intersection on Skyline Boulevard is in the Daly City Police Department area of responsibility for traffic collisions, and the roadway is maintained by Caltrans. The Highway 1 off-ramp is also maintained by Caltrans. Captain Clements will obtain additional information and share this at a future meeting.

Commissioners shared concerns about motorists driving in the fog, and proposed some sort of public service announcement on the topic (PSA). Captain Clements will research strategies to raise awareness about driving in the fog.

The Commission agreed to participate in the 18<sup>th</sup> Annual Disaster Preparedness Day Event being held at the San Mateo County Event Center on July 30, from 10am-2pm.

The Commission also discussed hosting a booth at the 2022 Fog Fest, on September 24 and 25, 2022. There will be more information at upcoming meetings.
